INVITATION TO BID

PUBLIC BIDDING OF

ONE (1) LOT SUPPLY, DELIVERY AND INSTALLATION, TESTING COMMISSIONING OF ONE (1) UNIT NEW BED ELEVATOR

1. The **PHILIPPINE ORTHOPEDIC CENTER (POC)**, through Hospital Income CY 2021, intends to apply the sum of **Five Million Five Hundred Thousand Pesos (PhP 5,500,000.00)** being the **Approved Budget for the Contract (ABC)** to payments under the contract for **One (1) Lot Supply, Delivery and Installation, Testing Commissioning of One (1) Unit New Bed Elevator**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The POC now invites bids for Public Bidding **One (1) Lot Supply, Delivery and Installation, Testing Commissioning of One (1) Unit New Bed Elevator**. Delivery of goods is **subject to availability of funds CY 2021**. Bidders should have completed, reckoned from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
