



PUBLIC BIDDING

1. The **PHILIPPINE ORTHOPEDIC CENTER (POC)**, through the General Appropriations Act (GAA) CY 2020 and Hospital Income CY 2021, intends to apply the sum of **TWENTY FOUR MILLION FOUR HUNDRED THIRTEEN THOUSAND EIGHT HUNDRED THIRTY FOUR PESOS AND 50/100 (PhP 24,413,834.50)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Public Bidding for the Supply and Delivery of FOODSTUFF (JULY-DECEMBER 2021)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The POC now invites bids for **PUBLIC BIDDING** for the **SUPPLY AND DELIVERY OF FOODSTUFF (JULY-DECEMBER 2021)**. Delivery of goods is **on need basis and subject to availability of funds CY 2021**. Bidders should have completed, reckoned from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Prospective bidders may obtain further information from POC and inspect the Bidding Documents at the **Office of the BAC, Ground Floor near Supply and Property Section POC, Maria Clara cor. Banawe Streets, Brgy. Lourdes, Quezon City**.
5. A complete set of Bidding Documents may be purchased by interested Bidders starting **May 21, 2021 (Friday, 8:00 A.M. to 4:00 P.M only)** from the Office of the BAC, Ground Floor near Supply and Property Section, POC, Maria Clara cor. Banawe Streets, Brgy. Lourdes, Quezon City and upon payment of a nonrefundable fee for the Bidding Documents.
6. The POC will hold a **Pre-Bid Conference** for the project on **May 31, 2021 (Monday) @ 9:00 A.M. at the Conference Room, Auditorium Complex, 3rd Floor, POC, Maria Clara cor. Banawe Streets, Brgy. Lourdes, Quezon City** which shall be open to all interested parties.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before the time and date specified below. Late bids shall not be accepted.
