**INVITATION FOR NEGOTIATED PROCUREMENT**

*Supply and Delivery of Drugs and Medicines (June-December 2022)*

1. In view of the two (2) failed public biddings, the Philippine Orthopedic Center Bids and Awards Committee I (BAC I) invites interested bidders to participate in the negotiation for the **Supply and Delivery of Drugs and Medicines (June-December 2022)** with an Approved Budget for the Contract (ABC) of **Twenty Three Million Five Hundred Thirty Four Thousand Six Hundred Ten Pesos and 72/100 (PhP23,534,610.72)** in accordance with Section 53.1 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act."

2. The following eligibility and technical documents as well as the Financial Proposal Form (Annex C) shall be submitted (*in triplicate*) on or before **July 12, 2022, 9:00 AM** at the POC Conference Room, 3<sup>rd</sup> Floor, Auditorium Complex, Ma. Clara cor. Banawe Sts., Quezon City;
  - (a) Certification of PhilGEPS Registration (Platinum, reprinted).
  - (b) List of projects for FY 2022 (ongoing and completed government and private contracts);
  - (c) Bid security issued in favor of the Hospital shall be either in the following forms and amount:
    - (i) 2% of the ABC, if cash or cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit issued by a Universal or Commercial bank;
    - (ii) 5% of the ABC, if surety bond with certification from Insurance Commission that such insurance company is authorized to issue such security;
    - (iii) Any combination of the foregoing; or
    - (iv) Bid Securing Declaration.
  - (d) Compliance with the Schedule of Requirements (Annex A) and Technical Specifications (Annex B) which includes production/delivery schedule, manpower requirements, and/or after-sales/parts, if applicable;
  - (e) Omnibus Sworn Statement;
  - (f) Authority of the Signatory.
  - (g) Certificate of Product Registration (CPR), COE, or its equivalent, where applicable
3. Opening of the eligibility documents, technical documents and financial proposal will be on **July 12, 2022 at 9:00 AM**.

5. **Delivery of goods is on need basis and subject to availability of funds CY 2022 and Income 2022.**
6. **For awarded suppliers, Warranty Security would be required as indicated in Section 17.1 (k) and 62 of the 2016 Revised IRR of RA 9184.**
7. The POC reserves the right to accept or reject any offer, to annul the negotiation process, and to reject all offers at any time prior to contract award, without thereby incurring any liability to affected firms.
