



**INVITATION TO BID**  
for the  
**PUBLIC BIDDING FOR ONE (1) LOT SUPPLY, DELIVERY, INSTALLATION AND CONFIGURATION OF INFORMATION TECHNOLOGY (IT) HARDWARE**

1. The **PHILIPPINE ORTHOPEDIC CENTER (POC)**, through the General Appropriations Act (GAA) and Hospital Income CY 2022, intends to apply the sum of **TEN MILLION PESOS ONLY (PhP 10,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **One (1) Lot Supply, Delivery, Installation and Configuration of Information Technology (IT) Hardware**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The POC now invites bids for **PUBLIC BIDDING for One (1) Lot Supply, Delivery, Installation and Configuration of Information Technology (IT) Hardware**. Delivery of goods is **on need basis and subject to availability of funds** for FY2022. Bidders should have completed, reckoned from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
