



INVITATION TO BID

PUBLIC BIDDING FOR SUPPLY, DELIVERY AND INSTALLATION OF VARIOUS MEDICAL EQUIPMENT

1. The **PHILIPPINE ORTHOPEDIC CENTER (POC)**, through the General Appropriations Act (GAA) and Hospital Income CY 2022 intends to apply the sum of **THIRTEEN MILLION SIX HUNDRED FORTY THOUSAND PESOS (PHP 13,640,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for Supply & Delivery of Various Medical Equipment. Bids received in excess of the ABC shall be automatically rejected at the bid opening.

2. The POC now invites bids for Public Bidding for Supply & Delivery of Various Medical Equipment. Delivery of goods / equipment is **subject to availability of funds** for FY 2022. Bidders should have completed, reckoned from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from POC and inspect the Bidding Documents at the **Office of the BAC, Ground Floor near Supply and Property Section POC, Maria Clara cor. Banawe Streets, Brgy. Lourdes, Quezon City.**
