



**INVITATION TO BID**

**PUBLIC REBIDDING FOR  
SUPPLY AND DELIVERY OF SIX (6) UNITS IN LINE IV FLUID WARMER  
(FOR BLOOD TRANSFUSION)**

1. The **PHILIPPINE ORTHOPEDIC CENTER (POC)**, through the through the General Appropriations Act (GAA) and Hospital Income CY 2022 intends to apply the sum of **THREE HUNDRED SIXTY THOUSAND PESOS (PHP 360,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for Public Rebidding for Supply & Delivery of Six (6) Units In Line IV Fluid Warmer (For Blood Transfusion). Bids received in excess of the ABC shall be automatically rejected at the bid opening.

2. The POC now invites bids for Public Rebidding for Supply & Delivery of Six (6) Units In Line IV Fluid Warmer (For Blood Transfusion). Delivery of goods / equipment is **subject to availability of funds** for FY 2022. Bidders should have completed, reckoned from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from POC and inspect the Bidding Documents at the **Office of the BAC, Ground Floor near Supply and Property Section POC, Maria Clara cor. Banawe Streets, Brgy. Lourdes, Quezon City.**

5. The POC will hold a **Pre-Bid Conference** for the project on **July 18, 2022 (Monday) @ 10:00 A.M. at the POC -3<sup>rd</sup> Floor Auditorium Complex, Maria Clara cor. Banawe Streets, Brgy. Lourdes, Quezon City** which shall be open to all interested parties.
6. Bids must be delivered to the **POC -3<sup>rd</sup> Floor Auditorium Complex, Maria Clara cor. Banawe Streets, Brgy. Lourdes, Quezon City**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the **Instructions to Bidders Clause 14**.
