



INVITATION TO BID

PUBLIC BIDDING FOR ONE (1) LOT SUPPLY AND DELIVERY OF IT EQUIPMENT

1. The **PHILIPPINE ORTHOPEDIC CENTER (POC)**, through the General Appropriations Act (GAA) and Hospital Income CY 2022 intends to apply the sum of **ONE MILLION FOUR HUNDRED THIRTEEN THOUSAND PESOS (PHP 1,413,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for One (1) Lot Supply and Delivery of One (1) Lot IT Equipment. Bids received in excess of the ABC shall be automatically rejected at the bid opening.

2. The POC now invites bids for Supply and Delivery of One (1) Lot IT Equipment. Delivery of goods / equipment is **subject to availability of funds** for FY 2022. Bidders should have completed, reckoned from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
