



**INVITATION TON TO BID**

**PUBLIC BIDDING FOR VARIOUS SERVICES CY 2022**

1. The **PHILIPPINE ORTHOPEDIC CENTER (POC)**, through the General Appropriations Act (GAA) and Hospital Income CY 2022, intends to apply the sum of **TWENTY ONE MILLION NINE HUNDRED FORTY FIVE PESOS (PHP 21,945,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for Services in Various Categories listed below. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The POC now invites bids for Public Bidding for Services. Delivery of services is **subject to availability of funds** for CY 2022 Bidders should have completed, reckoned from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.  
  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Prospective bidders may obtain further information from POC and inspect the Bidding Documents at the **Office of the BAC, Ground Floor near Supply and Property Section POC, Maria Clara cor. Banawe Streets, Brgy. Lourdes, Quezon City.**
5.
